1. C40 Cities Climate Leadership Group

C40 is a network of nearly 100 mayors of the world's largest and most influential cities who are leading on delivering the urgent and most ambitious action needed right now to support a green & just COVID-19 recovery, limit global heating to 1.5°C and build healthy, equitable and resilient communities. While C40's greatest strength is its ability to unite the world's leading mayors around climate action, we are equally guided by city demand for tailoring of C40 services, especially within different regional contexts.

2. Summary and Background of the Project

The C40 Business Plan 2021-2024 and the C40 Leadership Standards set out global goals and commit to having regional priorities within them. C40 knows how we are delivering and reporting on the global goals, but we need to finalise how we are doing that for regional priorities for an effective regionally-coordinated delivery.

The Regional Business Plan for North America will be a guiding document on how the C40 Leadership Standards and each of the sections of the C40 Business Plan will be delivered in the region. It will be a document that will be shared with cities, funders and partners, but it will also include internal annexes anchoring the delivery and regional coordination of the Regional Business Plan.

C40 is seeking support from an external expert to help with external stakeholder and political mapping, identifying key areas for C40 to expand into to achieve regional priorities to inform the Regional Business Plan for North America. The work will also involve some consultation with internal and external stakeholders, in close collaboration with C40 staff leading on this project.

- Overall proposal suitability: ability to meet the scope and needs included in this document (40%)
- Value for money (30%)
- Expertise and experience of the bidder(30%)

The winning bidder will be notified of the outcome within 1 week of submitting the proposal. Contract terms and conditions will be negotiated upon selection of the winning bidder.

Should we put a common narrative forward for the region, or should we develop national narratives for both the US and Canada? • Who are new partners who can elevate the voice of mayors who C40 doesn't already engage with? What role can C40 play with those new partners? • How can C40 support mayors get mo
